- Additional extension can be request for October 15, 2020 due

# Income Tax

Timely and Accurate Preparation of Federal, State and Local Taxes

*Preparation*

# General Information

- ▶ Full name(s) and Social Security number(s)
- ▶ Date of birth
- ▶ Previous year's tax return for you and your spouse, either filing jointly or separate
- ▶ Bank account number and routing number for tax due and refund

# Income Documentation

- ▶ W-2 form(s)
- ▶ 1099-INT, 1099-DIV, 1099-B for interest, dividend & securities investment incomes
- ▶ 1099-R for retirement and annuities distribution, or rollover retirement funds
- ▶ 1099-G for unemployment income or state/local tax refunds
- ▶ 1099-C for debt cancellation

# Income Documentation (continued)

- ▶ 1099-MISC for independent contractor income, rental, royalties, or trustee fee income
- ▶ SSA-1099 for social security income
- ▶ 1099-S for sale of primary resident property or rental property
- ▶ 1099-SA for medical saving distribution
- ▶ Alimony received, Jury duty, gambling winnings

# Business Income & Expenses

- ▶ Business income and expenses
- ▶ Form K-1 from partnership, trust, or S-Corporation
- ▶ Rental income and expenses
- ▶ Personal property and equipment list with detailed schedule for current and prior years

# Expenses & Tax Deductions

- ▶ Health saving account contribution
- ▶ Moving expenses for job
- ▶ Alimony amount paid and recipient's social security number
- ▶ Retirement contribution
- ▶ Teacher's out-of-pocket expenses for classroom supplies
- ▶ 1098-E for student loan interest
- ▶ 1098-T for tuition paid for post-high school education



# Expenses & Tax Deductions (continued)

- ▶ 1098 for mortgage interest paid
- ▶ Medical, hospital, and nursing expenses
- ▶ Long-term care premium paid
- ▶ Real estate taxes paid
- ▶ State income tax liability taxes paid
- ▶ Charitable cash contribution(s)
- ▶ Medical and charitable mileage detail record

# Expenses & Tax Deductions

## (continued)

- ▶ Charitable non-cash contribution information, including fair market value, donee name, address and EIN
- ▶ Investment interest and fee expenses
- ▶ Casualty and theft losses, insurance reimbursement record
- ▶ Union and professional dues
- ▶ Last pay stub of the year
- ▶ Unreimbursed job expenses

# Expenses & Tax Deductions (continued)

- ▶ Last year's tax preparation fee
- ▶ Home office expenses, home size, and office size (square feet)
- ▶ Cost basis and date purchased information for securities and/or property sold
- ▶ Job hunting expense(s)

# Last but NOT least...

- ▶ Estimated taxes payment(s) for current year
- ▶ Prior year refund applied to current year
- ▶ Household employment records and quarterly reports
- ▶ Record of foreign tax paid
- ▶ Foreign bank account detail information, including name, address, account number, highest value during the year

# Last but NOT least... (continued)

- ▶ Household employment taxes paid and quarterly state filing records
- ▶ Advance health premium tax credit
- ▶ Adoption expense information
- ▶ Childcare expense amount and provider name, address, and EIN
